Minutes of the Meeting held under the Joint Chairmanship of Shri Rajiv Manjhi, Joint Secretary and Dr. Anil Kumar, Deputy Director General, DteGHS on 04.02.2022 at 12:00 Noon in Office Chamber of Deputy Director General (Leprosy) to discuss various issues and actions to be taken, arising out of the Hon'ble Supreme Court's Order dated 14.09.2018 in the Writ Petition (Civil) No. 767 filed in the year 2014 by Shri Pankaj Sinha against Union of India.

A meeting was held under the Joint Chairmanship of Shri Rajiv Manjhi, Joint Secretary and Dr. Anil Kumar, Deputy Director General, DteGHS on 04.02.2022 at 12:00 Noon in Office Chamber of Deputy Director General (Leprosy) to discuss various issues and actions to be taken, arising out of the Hon'ble Supreme Court's Order dated 14.09.2018 in the Writ Petition (Civil) No. 767 filed in the year 2014 by Shri Pankaj Sinha against Union of India. At the outset, Chairmen welcomed all the participants. Shri Rajiv Manjhi, Joint Secretary asked to start the discussion. It was mentioned that the Hon'ble Supreme Court of India issued certain directions to Union of India, interalia, this Department vide its order dated 05.07.2018 in a Writ Petition (Civil) No. 1151 filed in the year 2017 by Vidhi Centre for Legal Policy against Union of India. The directions were mainly related to Awareness / Sensitization Campaign, Dissemination of Action Taken, curability of disease (Leprosy), the disease not being contagious, Non-discrimination, Healthcare, rehabilitation of persons suffering from the disease, Education, Employment / Livelihood, Welfare and repeal of provisions where leprosy is treated as stigmatic disability. An Action Taken Compliance Report on the directions was required to be filed by Union of India and the States in the Hon'ble Supreme Court. Accordingly the Hon'ble Supreme Court's Order dated 05.07.2018 was forwarded to all concerned for compliance. Meanwhile, one more Order dated 14.09.2018 was passed by the Hon'ble Supreme Court in the Writ Petition (Civil) No. 767 filed in the year 2014 by Shri Pankaj Sinha against Union of India. This Supreme Court Order dated 14.09.2018 alongwith earlier Order dated 05.07.2018 was forwarded on 29.01.2021 to all concerned including concerned State Governments / UTs for In response, State Governments started furnishing compliance A reminder was also issued to all concerned on 04.10.2021 for implementation of directions of the Hon'ble Supreme Court. Subsequently, the Hon'ble Supreme Court passed Order dated 24.09.2021 in the Contempt Petition (Civil) No. 484 filed in the year 2021 filed by Shri Dibakar Bhoi & Ors. versus Dr. Megha Pravin Khobragade for non-compliance of directions given by the Hon'ble

Supreme Court in its order dated 14.09.2018 in the Writ Petition (Civil) No. 767 of 2014.

In the above background, directions given by the Hon'ble Supreme Court in its Order dated 14.09.2018 were discussed in details and following decisions were taken.

i.	The Union and the States are to undertake periodical national surveys for determining the prevalence rate and new cases detection rate of leprosy and, at the same time, publish and bring the reports of the National Sample Survey of Leprosy conducted in 2010-11 and subsequent thereto into the public domain. That apart, the activities of the National Leprosy Eradication Programme (NLEP) must be given wide publicity.	It was decided that reports / data / information relating to National Surveys will be put on the website of DteGHS. It was also decided that link of the website may be given wide publicity including in replies of the RTI Applications that information / report / data of such surveys are already available in public domain.
ii.	On leprosy day which internationally observed every year on the last Sunday of January, the Union of India along with all State Governments should organize massive awareness campaigns to increase public awareness about the signs and symptoms of leprosy and the fact that it is perfectly curable by the Multi Drug Therapy (MDT). Awareness should also be spread about the free availability of MDT at all government health care facilities in the country, the prescribed course for MDT treatment and all other relevant information related to MDT. The content and information contained in the awareness programmes should discontinue to use frightening images of people disabled with leprosy and instead use positive images of cured persons sharing their experiences of being cured of leprosy.	It was mentioned that such awareness campaigns are being organized every year at periodical intervals. It was felt that photographs of such campaigns may be uploaded on the website for wide publicity. With regard to availability of MDT, it was mentioned that drugs for curing leprosy are available in concerned hospitals and health care centers, rather in excess so much so that drugs are expired before their use by leprosy patients. Other directions are noted for compliance.

The Union and the States are to ensure that drugs for management of leprosy and its complications including the MDT drugs are available free of cost and do not go out of stock at all Primary Health Centres (PHCs) or as the case may be, public health facilities in the country;	disease is already excess in all hospitals health care centres

Health care to leprosy patients, at both Government as well as private run medical institutions, must be such that medical officials and representatives desist from any discriminatory behavior while examining and treating leprosy patients. In particular, it must be ensure that there is not discrimination against women suffering from leprosy and they are given equal and adequate opportunities for treatment in any hospital of their choice. xiv.	The Union and the State Governments must pro-actively plan and formulate a comprehensive community based rehabilitation scheme which shall cater to all basic facilities and needs of the leprosy affected persons and their families. The scheme shall be aimed at eliminating the stigma that is associated with persons afflicted with leprosy.	It was decided that this issue may be taken with the Ministry of Social Justice and Empowerment by the Programme Division.
xv.	The Union Government may consider framing separate rules for assessing the disability quotient of the leprosy affected persons for the purpose of issuing disability certificate in exercise of the power granted under the Rights of Persons with Disabilities Act, 2016 (No.49 of 2016)	It was mentioned that this matter will be taken up separately by Programme Division.

With regard to the Hon'ble Supreme Court's Order dated 29.09.2021 in the Contempt Petition (Civil) No. 484 filed in the year 2021 by <u>Shri</u>

<u>Dibakar Bhoi & Ors.</u> versus Dr. Megha Pravin Khobragade for non-compliance of directions given by the Hon'ble Supreme Court in its order dated 14.09.2018 in the Writ Petition (Civil) No. 767 of 2014, it was felt that an enquiry under the Chairmanship of Joint Secretary (RM), involving ADG (L), DADG (L) may be conducted into the shortcomings pointed out in the representation (s) and the follow up steps taken by the concerned Department / Section.

It was also decided that in case the above directions have already been sent to all concerned including State Governments / UTs for compliance, a reminder letter may also be sent requesting them to furnish updated status on the compliance of the above mentioned directions of the Hon'ble Supreme Court.
