UPON hearing the counsel the Court made the following

**O R D E R**

The grievance in this petition is essentially about the non-compliance of direction given by this Court vide judgment and order dated 14.09.2018 in Writ Petition (C) No. 767 of 2014.

Instead of entertaining this contempt petition, we deem it appropriate to allow the petitioners to make a representation to the Director General (Leprosy), Directorate General of Health Services (Central Leprosy Division), New Delhi, which be considered in right earnest. If necessary, the stated Authority may direct or cause to conduct appropriate enquiry into the shortcomings pointed out in the representation(s) and the follow up steps taken by the concerned department/Section. In case, shortcomings have not been removed as predicated in the stated decision of this Court, in its letter and spirit, that be done within four weeks from the date of completion of such enquiry. The enquiry be completed, as aforesaid, within four weeks from the date of receipt of representation from the petitioners or any other interested public-spirited person.

The representation(s) and the compliance report be also contemporaneously placed in public domain/official website of the department concerned, so that the same becomes known to all concerned and correctness whereof can be put in issue, if and when required.

We are issuing direction to take corrective and remedial steps within four weeks as that direction had been issued by this Court as back as on 14.09.2018 and therefore, it cannot brook any further delay. This contempt petition is disposed of in the above terms.

2. That Shri Dibakar Bhoi, Petitioner No. 1 in Contempt Petition (Civil) No. 484 of 2021 before Hon'ble Supreme

Court of India submitted Representation dated 11.10.2021 to this Hon'ble Authority as per direction vide Order Dated 24.09.2021. This Applicant is a Petitioner No. .... /Non Petitioner to Contempt Petition (Civil) No. 484 of 2021 and is entitled to be rehabilitated in Indian Railways (South Eastern Railway and East Coast Railway) vide Order Dated 24.09.2021 in CPC No. 484 of 2021 read with earlier Orders Dated 17.08.1987, 26.07.1988, 06.01.1990, 24.07.1989 & 15.01.1990 of Hon'ble Supreme Court of India in Civil Appeal No. 1749 of 1987 – which are elaborated in details by Shri Dibakar Bhoi in his representation dated 11.10.2021 to this Hon'ble Authority.

- 3.1. My Original Certificate of Disability is under the custody of South Eastern Railway as per binding decision of Hon'ble NCDRC, New Delhi vide Order Dated 20.07.2020 in Appeal Execution No. 51 of 2019 which are under execution before the SCDRC, Odisha, Cuttack which directed South Eastern Railway to produce the reconstructed certificate of disability of this applicant by Order Dated 05.07.2021 and the said Order is as under:

“Heard the learned counsel for both the parties.

The complaint case No. 29/2011 appears to have not tagged to the above E.A. case.

Let C.C. No. 29/2011 be tagged to this E.A. case .

At the same time, Mr. Lokesh Kumar, Advocate for Railway is directed to take further instruction if the reconstruction of documents available should be produced to pass necessary order in the E.A. case.

List this matter on 30.07.2021 for further hearing.”

- 3.2. That SCDRC, Odisha, Cuttack by Order Dated 11.10.2021 directed Chief Personnel Officer(Admn.), SE Railway, Kolkata – 700 043 to enter his personal appearance before SCDRC, Odisha, Cuttack with reconstructed records and affidavit on 15.12.2021 positively without fail.
4. As per direction of Hon'ble Supreme Court of India this Hon'ble Authority is required to cause an inquiry with the Ministry of Railways, South Eastern Railway & East Coast Railway on the basis of Orders Dated 20.07.2020 of Hon'ble NCDRC, New Delhi and of Order Dated 05.07.2021

of SCDRC, Odisha, Cuttack within four weeks and for publishing this my representation dated 11.10.2021 with compliance report of this Hon'ble Authority as directed by Hon'ble Supreme Court of India by Order Dated 24.09.2021.

5. That this Applicant is also one of the victims of corruption by A.K. Mohapatra, Deputy CPO(HQ), SE Railway, Kolkata - 700 043 who behaved like private litigants with hidden profiteering motive violating binding laws laid down by Hon'ble Supreme Court of India in Judgment Dated 30.10.2009 in SLP(C) No. 29852 of 2009(CC No. 11768) and therefore this Applicant is entitled to suitable compensation in terms of Para 4 of Judgment dated 30.10.2009 in SLP(C) No. 29852 of 2009(CC No. 11768) of Supreme Court of India and said para 4 are as under:

“4. It is a matter of concern that such frivolous and unjust litigation by governments and statutory authorities are on the increase. Statutory Authorities exist to discharge statutory functions in public interest. They should be responsible litigants. They cannot raise frivolous and unjust objections, nor act in a callous and highhanded manner. They can not behave like some private litigants with profiteering motives. Nor can they resort to unjust enrichment. They are expected to show remorse or regret when their officers act negligently or in an overbearing manner. When glaring wrong acts by their officers is brought to their notice, for which there is no explanation or excuse, the least that is expected is restitution/restoration to the extent possible with appropriate compensation. Their harsh attitude in regard to genuine grievances of the public and their indulgence in unwarranted litigation requires to be corrected.”

6. Therefore, I am earnestly praying to this Hon'ble Authority to kindly consider this representation dated 11.10.2021 and publish the status on the official website and transmit my this representation to Indian Railways(South Eastern Railway & East Coast Railway) for providing urgent rehabilitation to me with other benefits as per Judgment Dated 14.09.2018 in WPC No. 767 of 2014 and as per Order dated 24.09.2021 of Hon'ble Supreme Court of India passed in Contempt Petition Civil No. 484 of 2021 and Orders Dated 17.08.1987, 26.07.1988, 06.01.1989, 24.07.1989 & 15.01.1990 in Civil Appeal No. 1749 of 1987

of the Hon'ble Supreme Court of India within four weeks without any further delay and without fail.

7. This applicant is also praying to this Hon'ble Authority to display this Representation along with Action Taken Report on Official Website under intimation to this applicant as directed by the Hon'ble Supreme Court of India within Seven days after receipt of this representation. In the event of not displaying this representation with action taken report within seven days after receipt of this representation will amount Contempt of Hon'ble Supreme Court of India in Contempt Petition (C) No. 484 of 2021 and this applicant will again approach the Hon'ble Supreme Court of India by way of a fresh Contempt Petition through efilling for which this representation kindly be treated as notice of motion for initiating contempt proceedings against violation of Order dated 24.09.2021 in Contempt Petition (C) No. 484 of 2021 of the Hon'ble Supreme Court of India.

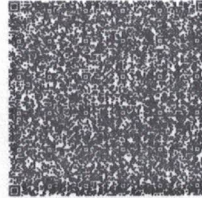

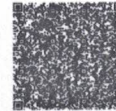
