Following works relating to the Transplantation of Human Organs Act (THOA), 1994, Rules 1995, Amendment Rules, 2008, Amendment Act, 2011 and Rules 2014 are being looked after:

- I. Registration and organizing inspections of Hospitals (Govt. & Private) located in all Union Territories except Delhi for various organs & Tissues(i.e. Kidney, Liver, Heart, Pancreas, Intestinal, Cornea, & Eye Bank) under Transplantation of Human Organs Act for five years.
- II. Renewal of registration and organizing inspection of hospitals registered under THOA after expiry of registration.
- III. Submission of registration/renewal fees received from various hospitals to Cash Section for depositing in the Govt. account.
- IV. Parliament Question relating to THOA.
- V. VIP matter relating to THOA
- VI. RTI matter relating to THOA.
- VII. Court cases relating to THOA.
- VIII. Meeting of experts to be organized for hearing the Appeals received from the Appellants on rejecting their organ transplantation by the Authorisation Committee of various Hospitals.
- IX. Maintaining Various organ transplantation data received from the registered hospitals under THOA.(24 hospitals registered for kidney transplantation, 10 hospitals for Heart transplantation, 8 hospitals for Liver transplantation, 2 hospitals for Intestinal, 3 hospitals for Pancreas and 55 hospitals for Cornea & Eye Bank).
